#### REGISTRATION

All registration of participants (managers, coaches and athletes) must be registered through the Malaysia Archery Results & Entry Online System (MAREOS). No manual registration is accepted.

Affiliates are required to sign in at MAREOS via <a href="https://mareos.masarchery.org/">https://mareos.masarchery.org/</a> by using the email address and password set by NAAM. After check-in, select the tournament you want to register.

#### CATEGORY

The categories for this tournament are as follows:

- Recurve Men (ages from 13 and above) RM.
- Recurve Women (ages from 13 and above) RW.
- Compound Men (ages from 13 and above) CM.
- Compound Women (ages from 13 and above) CW.

#### **PARTICIPATION**

The organizers do not limit the participation. Each team can submit entries according to the needs of their respective teams.

Entries from overseas and non-citizens of Malaysia must send an email of passport and passport-sized photo to the <a href="mailto:RMNarchery@gmail.com">RMNarchery@gmail.com</a> before 20 April 2024 for the entry process in the Lumut TLDM Base.

Late registration (after the closing date) or any changes (after the closing date) will be fined at a predetermined rate and the organizer has the right not to accept.

The entry fee is as follows:

Archer

: RM150.00/person

Officer

: RM40.00/person

The penalty/penalty rate for late registration/ exchange is RM20.00/person.

The exchange of athletes for reasons of injury is exempt from payment of fines. Please include a confirmation letter from the medical doctor.

## **PAYMENT INFORMATION**

Payment must be made after the team manager's briefing on 22<sup>nd</sup> May 24 on a **Cash** basis only. After the date, the penalty rate will be charged.

#### **RULES AND REGULATIONS**

- 1. Apart from the regulations contained, the competition will be conducted in accordance with the laws of *World Archery* and the National Archery Association of Malaysia.
- 2. If any disagreement arises in terms of its interpreter, then the latest World Archery laws will be complied with. Unforeseen events and not specified in the relevant regulations will be decided as follows:
  - Any event will be disconnected based on the rules of National Archery Association of Malaysia.
  - b. Any technological disagreements will be decided based on World Archery Law and National Archery Competition.
  - c. Any decision made by the Technical Committee and The Championship competition is final.
- 3. Only Team Managers are allowed to object. The objection must be made in writing and accompanied by a wagering fee of RM300.00 (Malaysian Ringgit Three Hundred Only). The wagering money will lapse if the objection submitted is rejected or found to be improper.
- 4. Each objection must be sent to the Competition Manager within 15 minutes after the results are announced.
